

## **Terms & Condition**

Thank you for registering for MBCS25! We're excited to have you join us. Before you purchase your ticket and attend the event, please take a moment to review these Terms and Conditions. By purchasing ticket(s), you agree to follow these guidelines. ### **1. Ticket Purchase and Registration**

- All tickets for MBCS25 should be purchased through the official website for MBCS25 or via one of the breast cancer support groups partnering TalkHealthAsia for MBCS25 and authorised by TalkHealthAsia to conduct bulk sale of tickets to the event.
- Tickets are available on a first-come, first-served basis. So be sure to purchase yours early!
- Please ensure that all details you provide when purchasing ticket(s) are accurate, and let us know soonest possible if anything changes.
- By purchasing ticket(s) to MBCS25, you're confirming the intention of ticket holders to attend the event and agree to the terms set out here.

### **2. Event Changes or Cancellations**

- **Changes to the Event:** If for any reason a need arises to adjust the event schedule, content, or venue, we'll notify you as soon as possible.
- **Event Cancellation or Postponement:** If MBCS25 is cancelled or rescheduled, you'll be eligible for a full refund. Please refer to our Refund Policy for more details.
- **Other Costs:** Unfortunately, we are unable to cover any other costs or inconvenience caused by event changes. We recommend checking your email for any important updates leading up to the event.

### **3. Refunds and Transfers**

- If you need a refund, please follow the steps outlined in our Refund Policy.
- If you can't attend the event, you may transfer your ticket to someone else. Just let us know the new attendee's name and mobile number, but please do this at least 30 days before the event. Transfers are subject to TalkHealthAsia's approval.
- We're unable to provide refunds for any other reason including a "change of mind," scheduling conflicts, or if you're unable to attend without prior notice.

### **4. Ticket Use**

- Your ticket is for the personal use of registered individuals only, and we ask that you do not resell or transfer ticket(s) without our prior approval, to ensure all event details are seamless.
- When you arrive at the event, please show your ticket—either a printed copy or a digital version—at the registration desk to gain entry. We won't be able to admit you without it.

## **5. Behaviour at the Event**

- We hope to provide everyone with a positive and enjoyable experience. Please ensure that your behaviour is respectful of others. If any attendee is disruptive or behaves inappropriately, we reserve the right to ask them to leave.
- You're responsible for your personal belongings during the event. We are unable to accept liability for any loss or damage of belongings, or any personal injury that occurs.

- You're attending MBCS25 at your own risk and are responsible for your health and safety while at the event.
